Researcher is responsible to submit a summary up to 12 pages of his/her research work that will be used for publication of internal bulletin in the institute. 4. Researcher is responsible to pay back the sum of the expenses, which are not evidenced by the acceptable documents and unused fund. 4. The researcher will be accountable if he/she fails to justify the financial expenses. 5.
